In view of the Notification No.75, dated 4th September 2021 issued by the Principal Seat of the Gauhati High Court and also upon considering the representation dated 06th September 2021 submitted by the Gauhati High Court Itanagar Permanent Bench Bar Association seeking resumption of physical court and reopening of Bar room and canteen, the Gauhati High Court, Itanagar Permanent Bench has been pleased to issue following guidelines pertaining to resumption of physical Courts and re-opening of the Bar room as well as Canteen in the precincts of the High Court.

- Cases shall be heard in physical mode. (i)
- Bar room shall be permitted to be opened with 50% of its seating capacity by (ii) adhering to COVID-19 (protocols) issued by the Government from time to time. The Bar Association shall give an undertaking to the Registrar that all COVID-19 protocols shall be maintained and that they shall be responsible for adhering to COVID-19 guidelines issued by the Gauhati High Court.
- The Executive members of the Bar Association shall constitute a team for ensuring (iii) that there is no overcrowding in the Court as well as Bar room and COVID-19 protocols are maintained. Further, the team shall ensure that no unauthorized person is allowed entry into the Bar room.
- (iv) The canteen may be opened only with 50% of its seating capacity and not more than 02(two) persons shall be permitted to seat in one table.
- Wearing of face mask within the Court premises shall be mandatory. (V)
- Entry of litigants in the premises of the High Court shall continue to be prohibited, (vi) except when the litigant is the petitioner-in-person or when the personal appearance of the litigant is required, in a case as may be verified by the concern Advocate.
- Entry of any person in connection with any important work inside the Court (vii) premises shall be allowed with the prior permission of the Joint Registrar or in his absence by the Deputy Registrar (Judicial).
- In view of the resumption of physical Court in the Gauhati High Court, Itanagar (viii) Permanent Bench, all type of cases would be listed as usual.

This Notification shall come into effect from 09.09.2021 and remain in force until further order.
