Heard Mr. J. Hussain, learned counsel for the accused applicants. Also heard Mr. I. Basar, learned Addl. Public Prosecutor for the respondent State of Arunachal Pradesh.

It is submitted by Mr. Basar, learned Addl. Public Prosecutor that on the strength of interim bail order dated 21.12.2010 passed by this Court in A.B. No. 29(AP)2010, the court of learned Judicial Magistrate, First Class, Koloriang, has enlarged the present accused applicants on bail without waiting for the outcome of the instant bail application.

It is also submitted by Mr. I. Basar, learned Addl. Public Prosecutor that bail order was granted by the court of learned Judicial Magistrate, First Class, Koloriang, without there being any application for bail and without perusing the relevant CD.
