Heard Mr. D. Panging, learned counsel for the applicant. Also heard Mr. H. Chada, learned counsel, representing Mr. M. Batt, who appears for the respondents in the connected writ proceeding.

This misc. application is filed seeking correction of typographical errors in the court's order dated 21.01.2011 passed in WP(C) 56(AP)2010.

It is pointed out by Mr. Panging, learned counsel, that in paragraph 4 of the order, instead of Section 174 I.P.C., Section 172 I.P.C., is erroneously reflected. Similarly, in paragraph 6 of the same order, instead of Section 195 of the Code of Criminal Procedure, 1973, Section 145 of the Code of Criminal Procedure, 1973, is erroneously typed out. Mr. Chada, learned counsel, submits that he is agreeable to correction of the above errors.

In view of the above, in court's order dated 21.01.2011 passed in WP(C) 56(AP)2010, in paragraphs 4 and 6, the correct reference is to be noted as Section 174 I.P.C. and Section 195 of the Code of Criminal Procedure, 1973, instead of as reflected. The court's order dated 21.01.2011 is accordingly rectified.

This misc. application stands allowed incorporating the above corrections in the court's order dated 21.01.2011 passed in WP(C) 56(AP)2010.
