The appointment will automatically stand terminated after the expiry of the aforesaid period.
2. The appointment may be terminated even before the expiry of the aforesaid period if the work or conduct of the appointee is found unsatisfactory.
3. The appointed Technical staff for Live Streaming/ eSewa Kendra shall report for duty within 02 (two) days from the date of issue of this Order, failing which the post shall be filled with by the person in the wait list.
4. 01 (one) month notice shall be required before resigning from the post, failing which the Registry may take necessary action as deemed fit.
5. The candidate under no circumstances can claim regularization of service. The High Court reserves the right to discontinue the services of the selected candidates during the period of contractual engagement without assigning any reason thereof.
