FOR ISSUANCE OF NEW VEHICLE ENTRY PASSES

It is for general information of all concerned that all the existing Vehicle Entry Passes presently in use for entry inside the premises of the Gauhati High Court, Itanagar Permanent Bench at Naharlagun, shall stand **CANCELLED** and will no longer remain valid from **03.08.2026** onwards. Therefore, all the learned Judicial Officers, learned Advocates, Staff of the High Court/District Courts, Government Officers/Staff and others are requested to apply fresh applications for issuance of **NEW VEHICLE ENTRY PASSES** through the online portal within the stipulated period mentioned below:

- **Starting Date for Online Application:** **03.06.2026**
- **Last Date for Submission of Application:** **30.06.2026 till 5:00 PM**

It is further informed that the newly issued Vehicle Entry Passes shall become operational with effect from **03.08.2026** therefore the new Vehicle Entry Passes must be collected after summer break and not later than **01.08.2026**. After **03.08.2026**, entry of all vehicles into the High Court premises shall be strictly permitted only on production of the newly issued Vehicle Entry Passes. In view of the space constraints, first preference shall be given to the learned members of the Gauhati High Court Itanagar Permanent Bench Bar Association, Naharlagun after due verification.


