Scheme of the written examination

Paper-I	100 marks to test the general knowledge, aptitude, intelligence, test of comprehension and expression of law and General English including Essay writing on legal topic and information technology.
Paper-II	100 marks regarding objective questions and problems of law as regards the Transfer of Property Act, Civil Procedure Code, Code of Criminal Procedure, Bharatiya Nagarik Suraksha Sanhita (BNSS), Indian Evidence Act, Bharatiya Sakshya Adhinyam (BSA), Indian Penal Code, Bharatiya Nyaya Sanhita (BNS), Limitation Act.
Paper-III	100 marks consisting of judgment writing, legal theories and jurisprudence, provision of constitution of India.

NOTE: The candidates are expected to refer to the relevant decisions of the Apex Court and the High Court while writing answers in Paper II and III.

General Instructions :

(i) All candidates who obtain sixty percent or more marks or, corresponding grade in the written examination shall be eligible for viva voce examination.

Provided that Arunachal Pradesh Scheduled Tribe candidates who obtain fifty percent or

more marks or corresponding grade in the written examination shall be eligible for the viva voce examination.
