- (ii) Master's Degree in Physics/ Mathematics/ Statistics followed by Post Graduate Diploma in Computer Science/ Applications from a Government recognized University/Institution.
- (ii) B.Sc. (Computer Science or IT)/ BCA or B.Sc. in Physics/ Mathematics/ Statistics followed by Post Graduate Diploma in Computer Science/ Applications from a Government recognized University/ Institution.

  - **Experience Certificate** (if any) (must be in PDF JPEG).
  - **APST Certificate** (only for candidates belonging to APST category in PDF, JPEG format).
  - **Any Other Supporting Documents** (if any).

**e. Part-V: Confirmation Page**

- i. Candidate must carefully confirm all the details filled by themselves then proceeds to final submit. Once the application is submitted one cannot change the already provided information.
- ii. After submission of the application, candidate can download Application Summary for future reference.
