
//ORDER//

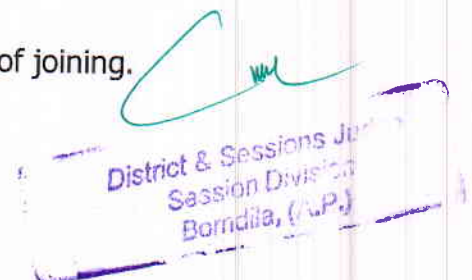

The appointment is made against the newly created sanction post vide order No. Jud-54/2013(Pt.III), dated 24.07.20219 and resultant resignation and promotional vacant.

The appointee should report for duties at the place of posting within 15 (fifteen) days from the date of issue of this order failing which the appointment shall stand cancelled.

The appointment will be subjected to the following terms and conditions:

- The appointment will be on probationary period of 2 (two) years.
- The appointment comes with its liability to serve in any parts of Arunachal Pradesh.
- The appointee should produce medical fitness certificate issued by Medical Officer not below the rank of Civil Surgeon, CMO/DMO to the effect that he is fit for Govt. Service.
- The appointment shall take effect from the date of joining.



- e. The appointment shall be subject to Character Antecedent and Police Verification report to be submitted in due course of time.

Other conditions of services which are not specified herein shall be governed by the terms and conditions and other relevant rules, and orders issued by the Govt. in force from time to time and Arunachal Pradesh State District Court Service Rules, 2013.
