Whereas, this office vide advertisement dated 09.03.2020 (published in Arunachal Times issue dated 10.03.2020 and website of Gauhati High court Itanagar Bench <http://ghcitanagar.gov.in/Notification/General/Khonsa/DSJ%20Khonsa%20Ad.pdf>) has invited aspirant candidate for filling of application for various posts under the Khonsa Division. Last date of filling of application was 20.04.2020, but due to Nationwide Lockdown in wake of COVID-19 Pandemic and non receipt of adequate application the recruitment process has not proceeded.

AND now, due to urgent exigency of supporting staffs the undersigned has contemplated to proceed with the recruitment process of filling application through online. Hence, it is ordered that advertisement dated 10.03.2020 is hereby reopen with the following modification.

- a. application has to be filled online through google form (link <https://forms.gle/kgwDr85Mq8w2qwZdA>)
- b. Before filling up the online form the applicant has to pay exam fee by visiting <https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=3755759> or by visiting www.onlinesbi.com >SBI collect > Select state of Arunachal Pradesh, Govt Department then Select District and Sessions Court Khonsa and fill up the required details (including post advertised and applied for) then make the payment of the exam fee as applicable.
- c. The transaction ID for the payment of the fee has to be mentioned on the online application form with same phone number and other details.
- d. That 09.09.2021 shall be date for consideration of maximum/minimum age.
- e. That last date of filling application is extended till 09.09.2021 (till 4:00 PM)
- f. That all other terms and condition not specifically mentioned herein above shall be remained same as advertisement dated 10.03.2020
- g. Candidate who has already applied need not apply again.


