
No. D&SJ/Tezu-Estt/Rcrmnt -Anini/01-2019/1403 Dated Tezu the 5th August'2021

This office vide circular No **D&SJ/Tezu-Estt/Rcrmnt-Anini/01-2019/683** dated **29th May'2020** has notified that the application fees paid by the candidates for the posts in pursuant to advertisement No **D&SJ/Tezu-Estt/Rcrmnt-Anini/01-2019/11-15** dated **21st Oct'2019**, and No **D&SJ/Tezu-Estt/Rcrmnt-Anini/01-2019/196-203** dated **11th Dec'2019**, shall be refunded by this office and accordingly, last date of submission of the details were given up to **06th July' 2020** however, this office has decided to give second chance to the those candidates, who has not applied for the same earlier. Accordingly, vide No **D&SJ/Tezu-Estt/Rcrmnt-Anini/01-2019/835** dated **27th Aug'2021**; the date was extended to **11th Oct'2020**, however still some of the applicants have not applied for the same.

The application fee will be credited in the bank account of the candidate, subject to the verification of details submitted by the candidate. If the candidate applied for more than one post then, separate proforma should be submitted for each post. The applicant shall check their emails or the official website for any updates regarding refund of fees. Further, candidates shall fill up the form completely however, if they don't remember the IPO/DD Number, they can keep it blank but other columns must be filled up.

Further, the candidates who have not submitted application fee or whose application has been received lately or whose demand draft has been returned by the bank shall not apply for refund of fess however whose application has been received lately or whose demand draft has been returned by the bank, they can file an application along with self addressed envelope for return the said demand draft from this office. List of such candidates has been annexed in the circular dated 27.08.2021.
