Heard Mr. T. Pertin, learned counsel for the petitioner and Mr. N. Lowang, learned Addl. Senior Govt. Advocate appearing on behalf of the official respondents.

The simple prayer of the petitioner is that she may be released from Govt. Secondary School, Buragaon, West Kameng District as per transfer and posting order No.ES.2/429/APT/08 dated 13-12-2010 to enable her to join at Govt. Middle School, Bomjir, Lower Dibang Valley District on medical ground. A copy of the medical certificate has been furnished to the effect that the petitioner is expecting delivery of child on 05-03-2011 and in fact the aforesaid transfer order was made on her request on the medical ground.

It is stated that the Deputy Director of School Education, West Kameng District, Bomdila inspite of direction from the higher authorities namely, the Director of School Education, Government of Arunachal Pradesh has not complied with the said transfer and posting order by releasing the petitioner from the aforesaid School. There is no instruction to the effect that the aforesaid transfer and posting order has been cancelled or modified by the authorities concerned. It can, therefore, be said that the aforesaid transfer order is still in force.
